INSTRUCTIONS TO AUTHORS

Congratulations on the acceptance of your paper for publication in *Journal of Nematology*. You will be notified by e-mail when page proofs are available at the Press's ftp site (in Portable Document Format [pdf]). At that time, we ask that you examine and correct the proofs as quickly as possible and respond to Dr. Lambert, preferably within 48 hours. It is important that all corresponding authors respond rapidly, as any that don't will delay publication of the journal issue.

Right now, we ask that you supply the information requested below. Please provide all information requested. An invoice for printed reprints ("offprint") and publication costs will be sent after the article is published. The actual invoice cannot be prepared until we know the actual number of printed pages, the number of ¹reprints you wish to order and the extent of the charges (if any) for alterations you make on the page proofs. The invoice will be submitted to the person you designate on this order form. If your institution requires a purchase order, supply us with one now (The Society of Nematologists' Federal Tax ID No. is 52-6045070). Please also complete the Copyright Transfer form (page 3 of this document).

The cost per printed page is \$US80.00 for SON members and \$US125.00 per printed page for nonmembers. As indicated on the following page, additional charges are levied for electronic and printed reprints and ²author alterations to the page proofs.
